



**Stacy Peardot Goudy**  
**Advanced & Masters Handling Workshop**  
**July 25, 26 and 27, 2008**

Stacy Peardot Goudy got started in agility in 1989. She has trained, shown and titled dogs from four different groups including Australian Shepherds, Border Collies, Jack Russell Terriers, Boxers and a German Wirehaired Pointer. She owns C SPOT WIN Dog Training in LaPorte, Colorado. Stacy is an agility veteran whose dogs have earned the entire alphabet soup of agility titles; far too many to list here!

Stacy has qualified for the USDAA Grand Prix of Dog Agility for the last 13 years in a row. Stacy and her dog Secret represented the US at the IFCS World Championships in 2002 and 2004. In 2006 Stacy and Able represented the US at the IFCS World Championships. In 2002 she won the individual gold and led the team to 1<sup>st</sup> place.

Stacy has co-authored Go the Distance with Bud Houston. The book is a workbook to teach your dog to work away and she has released volumes 1 and 2 of the Go the Distance Video series to accompany the book. Stacy is a popular seminar presenter who, in a very positive, upbeat style, encourages participants to give as much to the game as their dogs do.

This is only Stacy's second time in Ontario! Space is extremely limited. Please join us for a fun, action packed handling workshop with Stacy. The workshop will focus on course strategy and analysis for a more efficient run with tighter turns and better lines, resulting in better course times. The workshop will also delve into improving your body language to better your handling technique and on-course communication with your dog.

**Location:** This workshop will be held outdoors on grass in a fully fenced and gated regulation size ring. The site is located just east of the hamlet of Valentia in the City of Kawartha Lakes.

**Details Details:**

The workshop will be split into two sessions, each consisting of three half days working and the other half days auditing. The mornings are for handler/dog teams currently working/training at the Masters level. The afternoons are for handler/dog teams currently working/training at the Advanced level.

In order to participate dogs must be comfortable working in the presence of other dogs and be up-to-date on vaccines. There will only be one dog working in the ring at a time.

Working spots are very limited. Participants are required to attend all three ½ days as each day builds on the prior day's exercises. In order to secure a working spot pre-registration and a deposit are required. Space for auditors is unlimited.

Morning sessions – Masters teams

8:00 a.m. to 12:00 p.m. -- \$385.00 (including tax) -- price includes three half days working, auditing the afternoon sessions, continental breakfast, lunch, drinks and snacks.

Afternoon sessions – Advanced teams

1:00 p.m. to 5:00 p.m. -- \$385.00 (including tax) -- price includes three half days working, auditing the morning sessions, continental breakfast, lunch, drinks and snacks.

Auditing -- \$60.00 per day (including tax) – includes continental breakfast, lunch, drinks and snacks.

Please note that the fee for participants is for one handler/person. An auditing fee will apply for additional attendees. You may bring and participate with more than one dog, running one dog per exercise.
